Acceptable Use *AGREEMENT* for Students

Acceptable use means that I promise to use ALL technology resources with respect and responsibility. As a River Edge student, I understand that the use of technology resources is designed to support my education. If rules are broken, I may lose my privilege to use technology resources.

As a part of my learning experience in school and at home, I have permission to use technology. I agree to the following rules:

1. I will only use technology and the Internet for my schoolwork.
2. I will only save or store material that is assigned by my teacher.
3. I will keep my username, password, and personal information SAFE AND PRIVATE always. It is not to be shared or changed.
4. I will only play teacher approved games.
5. I will handle ALL technology devices GENTLY and with CARE (ie. Chromebooks, iPads, laptops, etc).
6. I will be POLITE and CONSIDERATE when I use the technology.
7. I will follow the STUDENT CODE OF CONDUCT and HIB (harassment, intimidation, and bullying) POLICIES. I understand that “**ONLINE**” behavior MUST FOLLOW the same appropriate standards as “**OFFLINE**” behavior.
8. I will notify the teacher if I have or see a problem using technology.
9. My teachers will ALWAYS monitor my work to make sure I am a GOOD DIGITAL CITIZEN.
10. Everything I post online combines to make my DIGITAL FOOTPRINT. **I will keep my DIGITAL FOOTPRINT appropriate.**
11. I will follow the teacher direction when using “GAFE” (Google Apps for Education).
12. Access to Social Media Networking is forbidden unless directed by the teacher. (i.e. Facebook, Instagram, SnapChat, etc.)
13. I will respect all laws concerning privacy (opening anyone else’s files, or taking or posting anyone else’s pictures), piracy (violating site licenses), plagiarism (using another’s work – words, pictures – without attribution), copyright, and viruses (any methods of corrupting existing files or systems).
